


CHICAGO COVID-19 UPDATE


There are 49,273 cases of COVID-19 and 2,380 deaths among Chicago residents as of June 13, 2020. There are an average of 228 new cases and 17 deaths every day. An estimated 43,689 residents have recovered.1

Confirmed daily COVID-19 cases and 7-day rolling average



Daily coronavirus 2019 (COVID-19) cases reported for Chicago residents with known specimen collection date. Results for several previous days are updated each day. Two cases with specimen collection dates prior to March 1, 2020 are not included in the graph.

COVID-19 testing and percent positivity, 7-day rolling average



Number of tests performed and percentage of tests that were positive averaged over 7 days. Includes molecular tests performed at state and private laboratories with known specimen collection date. Percent positivity is based on individuals tested. Tests performed between Jan 21 and Feb 29, 2020 are not included in graph. CDPH may not receive all non-positive results.

As of June 13, 2020, there have been 283,435 tests performed. The 7-day average is 4,123 tests per day, with a percent positivity of 7.7%.





Daily COVID-19 new hospitalizations and 7-day rolling average




Daily COVID-19 deaths and 7-day rolling average



Chicago resident coronavirus 2019 (COVID-19) cases who have died, by date of death. Results for several previous days are updated each day.


COVID-19 symptoms are similar to those of influenza, so monitoring influenza-like illness (ILI) may also help identify COVID-19. ILI activity in 2020 that is higher than what was experienced in 2019 could indicate the presence of COVID-19 in the community.

Percentage of daily emergency department (ED) visits due to influenza-like illness (ILI) in Chicago, 2020 vs. 2019



COVID-19-like illness (CLI) is a new tool used to help track trends in COVID-19 activity. An increase in the number and percentage of ER visits due to CLI could indicate an increase in COVID-19 activity in the community.
