


# CHICAGO COVID-19 UPDATE


There are 59,388 cases of COVID-19 and 2,759 deaths among Chicago residents as of July 27, 2020. There are an average of 240 new cases and 3 deaths every day. An estimated 53,676 residents have recovered.1





Daily COVID-19 cases reported for Chicago residents with known specimen collection date. Results for several previous days are updated each day. Two cases with specimen collection dates prior to March 1, 2020 are not included in the graph.

# COVID-19 testing and percent positivity, 7-day rolling average



Number of tests performed and percentage of tests that were positive averaged over 7 days. Includes molecular tests performed at state and private laboratories with known specimen collection date. Percent positivity is based on individuals tested. Tests performed between Jan 21 and Feb 29, 2020 are not included in graph. CDPH may not receive all non-positive results.

As of July 27, 2020, there have been 577,413 tests performed. The 7-day average is 6,867 tests per day, with a percent positivity of 5.4%.












Chicago resident COVID-19 cases who have been hospitalized, by date of first hospitalization. Results for several previous days are updated each day.

### Daily COVID-19 deaths and 7-day rolling average



COVID-19 symptoms are similar to those of influenza, so monitoring influenza-like illness (ILI) may also help identify COVID-19.

Percentage of daily emergency department (ED) visits due to influenza-like illness (ILI) in Chicago, 2020 vs. 2019




ILI activity in 2020 that is higher than what was experienced in 2019 could indicate the presence of COVID-19 in the community.

COVID-19-like illness (CLI) is a new tool used to help track trends in COVID-19 activity. An increase in the number and percentage of ER visits due to CLI could indicate an increase in COVID-19 activity in the community.
