


SBIF Opening in Austin

Equitable TOD (eTOD)

- Development that enables all people regardless of income, race, ethnicity, age, gender, immigration status or ability to <u>experience the benefits of dense</u>, <u>mixed-use</u>, <u>pedestrian-oriented development</u> <u>near transit hubs</u>.
- Prioritizes investments and policies that <u>close the socioeconomic gaps between neighborhoods</u>
 that are predominately people of color and those that are majority white.
- Elevate community voice in decision making processes and in realizing community-focused benefits such as affordable housing, public health, strong local businesses, and environmental sustainability, to name a few.
