The Chicago Community Trust Pre-Development Fund

There is foundational support available via competitive grants!

The Chicago Community Trust provides a pre-development grant up to \$100,000 to support community-based Black and Latinx developers and nonprofit organizations in covering the costs of pre-development services.

The grant is not a reimbursable grant, so project teams are encouraged to apply as early as possible in their planning stage.

As a Technical Assistance partner for the Trust, Community Desk Chicago is available to answer questions related to qualifications and the application process.
