Recycling is important, benefits everybody. But what is RMG proposing? Recycling keeps consumers scrap out of the landfill, supports other companies and vendors Location is important because of the space and infrastructure needs. E.g., the river needed to move raw materials. General Iron grew beyond space needs.

This is not General Iron. That operation was about 20 feet from the public and outgrew the location.

Employed hundreds of people over the years. Around 80% minority. Operation has been compliant. Good paying jobs with benefits.

-from their builiding. RMG refuses to fix their property and equipment. RMG should not be allowed to open a new company when they cant take care of current ones. Based on video. The community deserves better. Tired of being dumped on. There's no art center. Our neighborhood deserves the same opportunities as others.

It smells awful in the area. The emissions will not be clean.

Other perspective: There may be some old buildings, the facility itself is new. This community has the highest covid rate and asthma rate, respiratory issues will be exasperated.

Need to know that there will be sufficient monitoring and that it won't be dangerous. Community needs assurance, especially given past issues.
