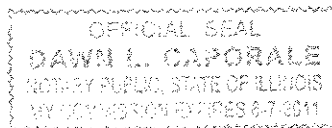

1. Please describe the major features of this project.

The existing shoring of one of the vaulted slabs of the Jackson Drive Viaduct is deteriorated and requires replacement. New shoring needs to be installed immediately to ensure structural integrity and public safety. The scope of work includes installing shoring, maintaining the shoring for six months till the structure is replaced and removal of shoring.

2. Please explain why this project could not be bid using the city's traditional bid process and the need to use JOC Procurement system.

CDOT has requested DPS to advertise the entire viaduct reconstruction project. However, the earliest a contractor could be in place to do this work is at least four (4) months away. This emergency item of work can not be performed by City Forces as it requires specialized personnel and equipment. Also, this item of work is not covered by an existing term agreement. It would not be time or cost effective for us to perform the work through the City's traditional bid process.
