

1. Please describe the major feature of this project.  
This project is installing new sidewalk that meets the requirements for A.D.A. ramps. This sidewalk was removed during the installation of the new residential street lighting project on Shields and Princeton from 55<sup>th</sup> to 57<sup>th</sup>. (JOC job J07-007.A)
