The Wells Street Bascule Bridge is in need of EMERGENCY structural repairs. The scope of work includes structural steel repairs to main truss and roadway stringers. These are primary members that support CTA Elevated Brown and Purple Lines as well as vehicular traffic. Pedestrian railing repairs are also required. This project requires coordination with the CTA and Coast Guard and late night work hours from a barge.

The proposed repairs are very complex as it involves coordination with the CTA and Coast Guard and due to restricted late night work hours from a barge.
