We will provide every Ward with 20 gallons of hand sanitizer for their communities upon arrival. Those picking up can park in our lot or in front of the distillery, and text Mark at 312-543-7092 upon arrival. The hand sanitizer will be brought out to their vehicle in a contact-free manner.
