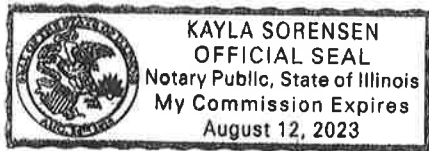


Dear Mr. George:

In response to your recent request, please be advised that the subject property is zoned DX-7 Downtown Mixed-Use District. Pursuant to Section 17-4-0207-AAA (1) of the Zoning Ordinance ("Ordinance"), an adult use cannabis dispensary requires special use approval from the Zoning Board of Appeals. Additionally, an adult use cannabis dispensary shall be located no closer than 500 feet from any school, pursuant to Section 17-9-0129 (3) of the Ordinance. According to our records, there are no schools within 500 feet of the subject property. The applicant will need to provide confirmation of this from the Illinois Board of Education as part of their special use application.

Finally, before a public hearing is held by the Zoning Board of Appeals to consider the special use application, the applicant must hold at least one community meeting in the ward in which it is proposed. Please refer to Section 17-13-0905-G of the Ordinance for more information about the community meeting process.

This letter may be used as your official denial to file for the required special use with the Zoning Board of Appeals.

NARRATIVE

MedMar Lakeview LLC 436 North Clark Street

MedMar Lakeview (the "Applicant") is proposing an early approval adult use dispensing secondary site location at 436 N. Clark St. to sell cannabis, cannabis-infused products including edibles, paraphernalia, and related items to eligible purchasers under the rules of the Cannabis Regulation and Tax Act (the "Act"). The location at 436 N. Clark St. will allow for eligible purchasers as defined under the Act to buy cannabis and cannabis-infused products for adult use with the same level of care and detail provided at MedMar Lakeview's primary location. The sole purpose of this secondary site is to serve eligible purchasers with the same level of care that medical use patients have come to expect from MedMar Lakeview.

The secondary site will provide similar daily operations to MedMar Lakeview, with applicable changes for adult use. Hours of operation will be 9 a.m. to 10 p.m. seven days a week and there will be approximately five (5) employees on site during Phase I and approximately 65 employees on site for the full build out, Phase II. The secondary site will allow purchasers to visit a dispensary, with the same security level and assurance as MedMar Lakeview. The ultimate size and the space of the dispensary will also eliminate the possibility of purchasers waiting and queuing outside and allow for more purchasers to take public transportation due to its proximity to the train and bus. This secondary site is intended to serve a growing market of eligible purchasers without causing undue stress on the neighborhood or any purchasers looking for relief.

The Applicant's training plan will ensure that employees understand the rules and laws to be followed by dispensary employees. Employees will also have knowledge of any security measures and operating procedures of the dispensary and can advise purchasers on how to safely consume cannabis and use individual products offered by the dispensary as required by the Act.

Dispensary agents will drive the purchaser's experience and will receive the established foundational training the Applicant uses at its existing medical dispensary on topics including dispensing cannabis product, consulting with purchasers about cannabis, and ensuring sales or transfers do not exceed purchasing limits. As required by the Act, all the Applicant's owners, managers, agents, and employees responsible for handling cannabis will complete a Responsible Vendor Program. The Applicant will use its own training program, as approved by the IDFPR ("Department"). Additionally, the Applicant will ensure each owner, manager, employee, and agent receives a minimum of eight (8) hours of training annually, unless otherwise approved by the Department and will have written policies and procedures in place regarding training. The Applicant will maintain evidence of all training it provides to each employee in its files, which will remain easily accessible on site and made available to the Department for inspection and audit, if necessary.

In accordance with the strict regulations promulgated by the state of Illinois and the city of Chicago, the Applicant will monitor the dispensary 24/7 to secure the premises, agents, and currency, and prevent the diversion, theft, or loss of cannabis. The Applicant will employ a robust security system that includes provisions for surveillance, product and currency containment,

restricted access areas, screening and monitoring employees, chain-of-custody, and preventing theft and loss. The Applicant will contract local security personnel responsible for patrolling the exterior of the premises. During business hours, security personnel will station at strategic areas around the interior of the dispensary and the exterior of the building and adjacent sidewalks. Security personnel will immediately report any discovery of suspicious behavior to the Security Director or designees, and to law enforcement, as necessary. Consistent with the Applicant's current policies and procedures, all dispensary personnel will wear identifying uniforms that will allow security staff to easily identify and differentiate employees on premises.

Staff will adhere to strict unloading/loading protocols and regulations related to receiving cannabis products including physical reception of the cannabis, inventory logging, and secure storage. Loading and unloading cannabis products will occur away from point-of-sales ("POS") areas and only a limited amount of staff will participate in receiving cannabis from secure transporters. Receiving will only happen in the presence of at least two employees including an Agent-in-Charge ("AIC"), plus security personnel.

The vault and cannabis storage areas will comply with all rules and regulations required by the IDFPR ("Department"). Storage areas will contain advance physical security, video surveillance, and access logging technology to protect cannabis and cannabis-infused products. The Applicant will require that all sales be paid in cash or by debit card. The Applicant will implement cash handling and deposit policies including regular register counts, counterfeit-detection markers, restricted access to cash safe keys, daily deposits in a drop-safe, and sufficient insurance coverage.

Phase I:

In order to quickly and safely begin dispensing cannabis the Applicant proposes building out the interior dispensary in two phases: the first to begin dispensary operations as quickly as possible while retaining safety and security, and the second to create more space within the dispensary to accommodate more purchasers. The Phase I area will be approximately 400 sq. ft. and will include all the necessary areas for an adult use dispensary, including a lobby, retail sales area, vault area, loading areas, and all "back of house" facilities including an office.

Phase I will comply with all State and City requirements while allowing for a quick build out to begin serving adult use purchasers as soon as possible. During Phase I of buildout, the first floor will include a security check in, lobby, retail sales area, vault area, and loading areas. The basement area will house the office and other employee-only amenities such as a break room. ADA-compliant restrooms will be located on the second floor during Phase I (please see the attached floor plans). There will be an ADA-compliant elevator to provide access to the bathrooms to purchasers and employees.

Consistent with current procedures that the Applicant employs at its currently operating medical dispensing organization, and to comply with 410 ILCS 705/15-70 (f), the Applicant will only accept cannabis deliveries into a restricted access area. Deliveries will take place in the alley on the north side of the building into the dispensary's restricted access area, where delivering procedures will take place before product is stored in the vault. Deliveries may not be accepted through the public or limited access areas unless otherwise approved by the Department.

Both Phase I and Phase II will utilize moveable lockable daily cannabis locker storage that can be moved in and out of the vault for ease of dispensing. Upon opening, the Agent-In-Charge (“AIC”) will remove the moveable lockable daily cannabis lockers out of the vault and the AIC will put them back into the vault upon closing. This will allow for secure dispensing, as the lockers will remain locked throughout the day except for during dispensing procedures and as an AIC replenishes any low stock items.

The Applicant hopes that the total timeline for opening Phase I is no longer than 7 weeks from ZBA approval of the Special Use, which includes obtaining a building permit and full Phase I buildout.

Phase II:

Phase II of the build out will utilize the entire first floor space while allowing for a minimal amount of interference with dispensary operations in the Phase I area. In Phase II, the retail sales area and lobby will be built out to allow for more purchasers to browse and learn about cannabis before making their selections. The space will allow for more Point-Of-Sale (“POS”) stations, providing an expedited dispensing procedure. In Phase II, the former Phase I space will be adjusted to create a larger security area to provide the same amount of security, but in a larger space for more purchasers to enter the building. Phase II will also add ADA-compliant restrooms to the first floor, allowing for better access to restrooms for both purchasers and employees.

In Phase II, the vault and dispensing procedures will remain the same. The vault will not move locations, and the only change for dispensing will be the location and amount of the POS stations. Building the dispensary out in phases will not compromise the dispensary in terms of security. Phase II will provide for a larger space allowing more purchasers to enjoy comfortable and expedited service.

Consistent with current procedures that the Applicant employs at its currently operating medical dispensing organization, and to comply with 410 ILCS 705/15-70 (f), the Applicant will only accept cannabis deliveries into a restricted access area. Deliveries will take place in the alley directly behind the building into the dispensary’s restricted access area, where delivering procedures will take place before product is stored in the vault. During Phase II, this area will be further built out with a dedicated receiving/eradication room and auxiliary storage area. Deliveries may not be accepted through the public or limited access areas unless otherwise approved by the Department.

The Applicant hopes that the total timeline for completing Phase II is nine (9) weeks from the ZBA’s approval of the Special Use Permit Application.
