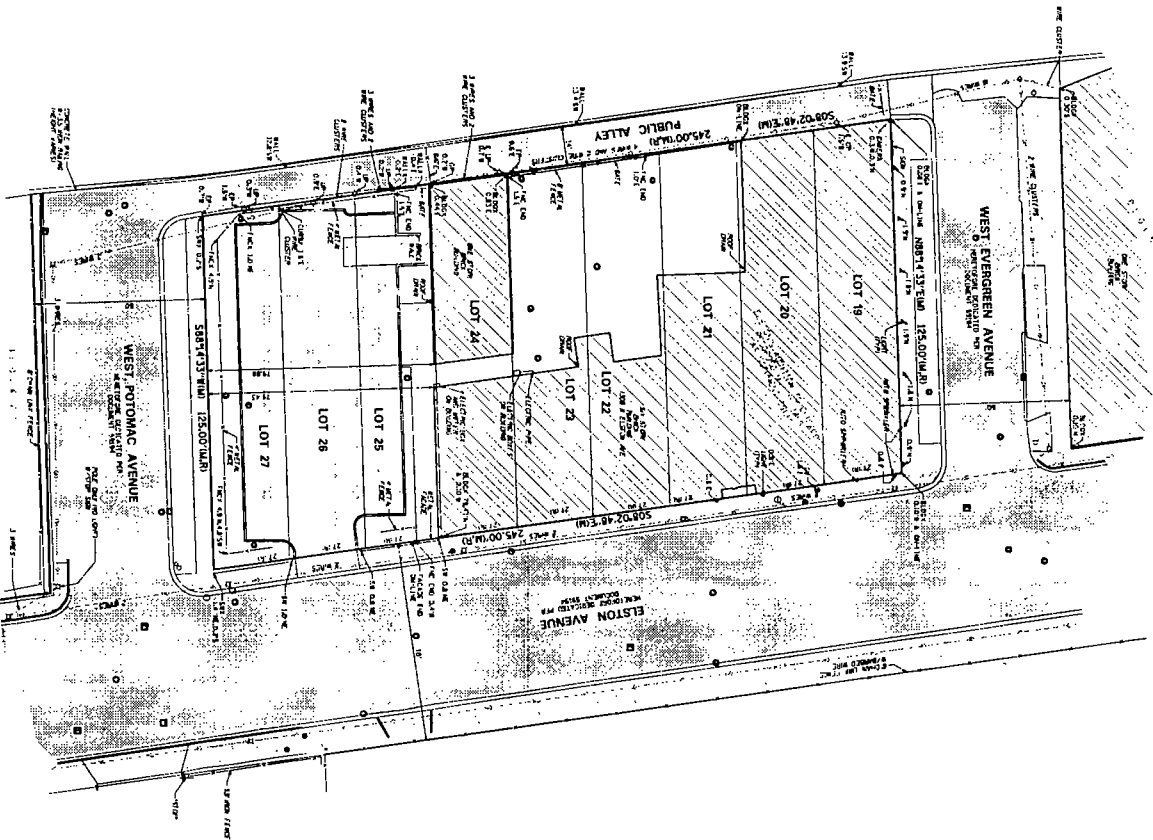
PLAT OF SURVEY
